THIS LICENSE IS SOLD ONLY TO RESIDENTS OF ARKANSAS WHO ARE 100% DISABLED WITH CERTIFICATION FROM SOCIAL SECURITY, VETERAN'S ADMIN., OR THE RAILROAD. THIS LICENSE IS VALID FOR THREE (3) YEARS WITH RE-CERTIFICATION REQUIRED FOR THE LICENSE TO BE RENEWED. PROOF OF 60 DAYS RESIDENCY IN ARKANSAS AND DISABILITY CERTIFICATION MUST BE FURNISHED. FAILURE TO PROVIDE ACCEPTABLE DOCUMENTATION WILL RESULT IN A DELAY IN PROCESSING.

DEFINITION OF TERMS. For the purposes of the Arkansas Game and Fish Commission Code of Regulations, the following terms shall be construed, respectively, to mean and include:

DISABLED-Any individual who is **100%** permanently and totally disabled as declared by the following federal agencies: the United States Social Security Administration, the United States Department of Veterans Affairs, or the United States Railroad Retirement Board.

A. Please provide one of the following documents:

1. **Social Security Award Letter or other notification dated within the last Three years verifying Title II or Title XVI disability**
 - **To obtain a copy of your letter or verification contact your local Social Security office**
 - **SSA1099 tax forms or copies of checks received are not acceptable**
2. **Veterans Admin. Arkansas Game and Fish Letter**
 - **Available only from the Regional Office in NLR; Fort Roots Bldg. 65**
 - **1-800-827-1000.**
3. **Railroad Retirement Board Letter of Determination (501) 324-5241**
 - **And a photocopy of the applicant's Medicare Card**

Commission Code 01.00-C defines a "Resident" for the above purposes as a person who:

Any person who physically inhabits a bona fide residence within Arkansas for a period of time no less than 60 days prior to applying for a license, and has declared citizenship in Arkansas.

Possession of Arkansas real estate by persons living outside the state does not qualify the owner as a resident.

Please Note: A **photocopy** of your current Arkansas driver's license or Arkansas I.D. card with **an issue date of 60 Days or older** will satisfy the proof of residency requirement.

An Arkansas driver's license or Arkansas I. D. card may be obtained from the nearest Department of Finance and Administration (DF&A) office.
