

New This Season

- White-fronted goose season is now 74 days with a 3-bird daily bag limit.
- Boat access restrictions on certain WMAs now include the seven days preceding the first day of the first segment of regular duck season. See pages 45-58.
- On Galla Creek WMA, the area accessible by boat from the Arkansas River Cutoff west of Flag Lake Road is excluded from boat and access restrictions. See Page 51.
- Federally approved nontoxic shot is only required for ducks, coots, mergansers and geese, except on certain WMAs and national wildlife refuges, where it is required for all migratory bird hunting. See Page 43.
- Applicants for special drawn permit waterfowl hunts will be limited to one application for WRICE program fields, one application for wildlife management draws and one application for youth blinds (if applicable) per application period.

Looking Ahead

- Regular duck, coot and merganser season in 2023-24 will be
 Nov. 25-Dec. 3, Dec. 9-23 and Dec. 27, 2023-Jan. 31, 2024
- Beginning in the 2023-24 waterfowl season, waterfowl hunting on Bell Slough, Ed Gordon Point Remove, Frog Bayou and Galla Creek WMAs and the Dyer Lake Unit of Ozark Lake WMA is limited to Tuesday, Thursday, Saturday and Sunday during regular duck season and all day on the last day of regular duck season.
- Beginning in the 2023-24 waterfowl season, the Special Youth Waterfowl Hunt will be the first Saturday and Sunday in February (Feb. 3-4).
- Beginning in the 2023-24 waterfowl season, the Special Veteran and Active-duty Military Waterfowl Hunt will be the first Sunday in February (Feb. 4).
- Beginning in the 2023-24 waterfowl season, all boats on the following WMAs will be required to have motors with only factory exhaust systems in place: Bell Slough, Beryl Anthony Lower Ouachita, Big Lake, Camp Robinson, Cut-Off Creek, Cypress Bayou, Dave Donaldson Black River, Dr. Lester Sitzes III Bois d'Arc, Earl Buss Bayou DeView, Ed Gordon Point Remove, Frog Bayou, Galla Creek, Harris Brake, Henry Gray Hurricane Lake, Petit Jean River, Rex Hancock Black Swamp, Seven Devils, Steve N. Wilson Raft Creek Bottoms, Sheffield Nelson Dagmar, Shirey Bay Rainey Brake and Sulphur River WMAs. The following national wildlife refuges also will follow this regulation change beginning in the 2023-24 season: Cache River, Dale Bumpers White River, Felsenthal and Overflow NWRs.

Season Dates Summary

Duck, Coot and Merganser

Nov. 19-27, 2022 • Dec. 10-23, 2022 • Dec. 26, 2022-Jan. 31, 2023

Duck daily bag limit – 6, which may include no more than:

4 mallards (2 hens), 1 scaup, 3 wood ducks, 1 pintail, 2 redheads, 2 canvasbacks, 2 black ducks, 1 mottled duck. If not listed, up to 6 ducks of a species (including teal) may be taken. **Coot daily bag limit** – 15.

Merganser daily bag limit – 5, which may include no more than 2 hooded mergansers. Possession limit for ducks, coots and mergansers is three times the daily bag limit.

Special Youth Waterfowl Hunt

Dec. 3, 2022, and Feb. 4, 2023 On these days, youths 15 and younger may harvest ducks, geese, coots and mergansers. Youths who have not completed a hunter education course must be accompanied by a mentor 21 or older. Mentors may not hunt, but may call waterfowl. Shooting hours and bag limits are the same as the regular duck and goose seasons. Youth hunters can hunt on wildlife management areas 30 minutes before sunrise until sunset these two days. WMA General Use Permits are not required for youth hunters.

Special Active Duty Military and Veteran Hunt

Dec. 3, 2022, and Feb. 4, 2023 On these days members of active duty military and military veterans may harvest ducks, geese, coots and mergansers. Active duty military includes members of the National Guard and Reserves on active duty (other than for training). Veterans must have served in active military, naval, air service or Reserves and National Guard on Title 32 orders in a combat zone and must have been discharged or released under Honorable conditions. Hunters will need to have an active hunting license and stamps and one of the following or copy during the hunt: DD214, Veteran Benefit Card, Retired Military I.D., Veteran Hunting License (VLF, VLH, VLC or VLL) or Military I.D. card. Shooting hours and bag limits are the same as regular duck and goose seasons. Hunters may hunt on wildlife management areas from 30 minutes before sunrise until sunset these two days. WMA General Use Permits are required.

Light Goose Conservation Order (Snow, Blue and Ross's)

Feb. 1-3, 2023 and Feb. 5-April 25, 2023. Special regulations apply during the conservation order.

- Hunters must call 833-345-0325 or go to www. agfc.com to receive a free snow goose registration permit (excludes youths 15 and younger).
- There is no bag limit or possession limit.
- Hunters may use electronic calls.
- Hunters may use unplugged shotguns.
- Hunters do not need a Migratory Bird Hunting and Conservation Stamp, Arkansas Waterfowl Stamp or HIP registration, but must have a valid hunting license from any state (excludes youths 15 and younger).
- Shooting hours are from 30 minutes before sunrise until 30 minutes after sunset.

Hail Calls: News You Can Use in 2022-23

Hurricane Lake Sees Some Help



Henry Gray Hurricane Lake WMA has been a major focus of the Arkansas Game and Fish Commission since 2018. That year, biologists found that a large portion of the WMA's southern greentree reservoir had suffered a major die-off of trees that provide the pair-bonding shelter and food resources mallards seek during their wintering period in Arkansas. In addition to changes in intentional water level management on the WMA, AGFC staff have guided contractors and engineers as they have worked to alter the infrastructure and improve the way water flows through greentree reservoirs.

Last fall, AGFC staff placed bridges and stream crossings on Mallard Pond Road on the WMA, partially reestablishing drainage when river conditions allow. The road was built on a natural high river bank, creating an impromptu levee. Using lidar, a high-detail elevation mapping technique, the AGFC identified seven water-control structures that required removal to promote free flow of water to and from the Little Red River. Contractors constructed five bridges and a low-water crossing that will allow water to flow out of the WMA when river levels allow and continue to provide good public access. A seventh water-control structure was removed, but building a crossing was unnecessary as it was beside the road and did not affect access.

Buck Jackson, the AGFC's statewide wetlands program coordinator, said the plug removal was only the first step in infrastructure changes on the WMA.

"Water needs to rise and fall more naturally through these systems if we want to keep the quality of the habitat they provide in the long-term," he said. "But keeping the water flowing when it is high is much more complicated than simply unplugging a drain. All that water has to have a place to go and the passages have to be large enough to pass the water efficiently. Otherwise it's like trying to drain a swimming pool with a garden hose."

Another major infrastructure change in progress is the addition of a new water-control structure on Glaise Creek, which was inadequate for the amount of water needed to drain through the WMA. The previous structure, which was only 40 wide, will remain but the reopened channel will allow much more water to flow.

"Engineers estimated that we needed at least 10,000 cubic feet per second of water to pass through the WMA when the White River hits 23 feet at the Augusta gauge," Jackson said. "The current infrastructure can't come close to keeping up with that volume of water."

Both of these projects are partially funded by North American Wetlands Conservation Act grants approved by the U.S. Fish and Wildlife Service. Ducks Unlimited worked with the AGFC to secure

these grants.

Jackson says the two projects on Hurricane are still only a portion of the work needed, and it's only one of the many WMAs with greentree reservoirs in need of updating and renovation.

"We're making better headway now than we've ever been able to before," Jackson said. "Seeing the results from every project completed gives us a little more inspiration to keep going with this monumental task."

Bayou Meto Management Changes Expand to Woods and Water



Last year marked the beginning of additional water management changes at George H. Dunklin Jr. Bayou Meto WMA. The AGFC limited any intentional flooding above 179 feet mean sea level on Bayou Meto's greentree reservoirs. During the 2022-23 season that level will again be lowered, to 178.5 feet msl. Below this elevation where the majority of Bayou Meto's red oak trees now showing signs of severe stress have been found.

AGFC Chief of Wildlife Management Luke Naylor, stresses that the limitation is only to intentional flooding, and that higher water levels are likely to occur should sufficient rain fall in Bayou Meto's watershed.

"That's just the highest level we're intentionally holding during the wintering period. The water will pulse over that if the rain comes and then recedes, creating a more natural flooding cycle. Last year saw

a few of these pulses and some great hunting for people watching for the new water. Gauge readings will be available at www.agfc.com/gtr."

Contractors also began the first stage of management and recovery on the area's bottomland hardwood forest within a portion of Upper Vallier and Government Cypress greentree reservoirs. Timber harvest is underway to make room for the next generation of forest.

Rob Willey, AGFC's statewide habitat program coordinator, worked with staff and contractors throughout 2021 and 2022 marking trees to be cut.

All forest management activities are being implemented above 178.5 feet msl to correlate with the modifications to water management.

"These trees are on the way out," Willey said. "We have to work to protect the healthy trees that remain to ensure that the red oak component continues in the future with improved water-management capabilities and practices that are being developed."

In addition to removing trees in poor health, the thinning operation will remove overcup oaks and other tree species that have less value to mallards. Overcup oaks are more water tolerant but do not provide the same benefits to mallards as the willow oaks and Nuttall oaks managers are trying to preserve, so more of these trees will be removed to make room for desirable species to flourish.

"About 75 percent of the trees marked for removal are overcup oaks," Willey said. "The remaining species targeted for harvest include green ash, red maple, elms, hickories, sugarberry and sweetgum. The overcups are creating a closed canopy that shades out the red oak regeneration, and the other species are adding to that competition for light and space by shading out red oak seedlings from the midstory."

Other AGFC-owned WMAs seeing forest thinning and timber harvest operations this summer include Hope Upland WMA, Sulphur River WMA, Mike Freeze Wattensaw WMA, Holland Bottoms WMA and Big Lake WMA. Roughly 5,000 acres of the 380,000 acres under AGFC ownership are

contracted for harvest operations to benefit wildlife, pending continued dry weather. During Fiscal Year 2022, the AGFC received \$372,305 from forestry operations (0.4 percent of the agency's revenue), all of which was redirected to improvements within the WMA system.

Renovation in full swing at Earl Buss Bayou DeView WMA



Greentree reservoirs in Earl Buss Bayou DeView Wildlife Management Area in Poinsett County also saw the beginning of major renovation work planned over two phases. Phase one began in early June with heavy machinery bringing in modern infrastructure to be installed in the WMA's Thompson Tract GTR.

Two large (15- and 18-feet wide) electrically powered metal overshot gates that can be operated remotely will replace two outdated 4-foot structures that used a screw gate and aluminum "boards" to retain water. The new water-control structures are going in at the Thompson Tract, in the middle of the WMA, and the South Oliver greentree reservoir, on the property's south end. Phase two, most likely beginning next summer, will add more water-control structures, rebuild levees and add spillways that will let spring and summer floodwater flow through the WMA more efficiently.

Much like on Hurricane Lake WMA, the work at Bayou Deview was partially funded through Ducks Unlimited and the North American Wetlands Conservation Act.

Some forest management work also has taken place at Bayou Deview. The WMA did not see as



much tree death as other areas, and a good amount of red oaks remain in the greentree reservoirs. The canopy is closed and needs to be opened to allow young red oaks to become established.

Bayou DeView is channeled in northeast Arkansas, unlike the winding parts of Bayou DeView found near Interstate 40 near Brinkley. The bayou's periodic flooding can cover nearby roadways over 1 foot deep. Spring floods are going to happen, but biologists have learned that moving water is much less

damaging than stagnant water held back by poor drainage.

Jason Carbaugh, an AGFC regional biologist based in Jonesboro, said, "It's natural for the area to flood in spring. When the 2021 duck season closed, I started pulling boards (after two large snowfalls) in February. Bayou DeView flooded and drained five times from March through July. This past spring it flooded (and drained) four times after duck season closed. These new structures that we're putting in, as well as renovating levees and putting in large spillways, will allow those natural spring floods to flow through these WMAs at a much more efficient rate, improving forest health and regenerating red oak communities."

Steady hunter numbers post slight increase in 2021 harvest

Duck stamp sales and active hunter estimates in Arkansas last year were nearly identical to the 2020-21 waterfowl season. In 2021-22, hunters purchased 101,877 state duck stamps, an increase of only 37 stamp sales from the 2020-21 sales of 101,840. Resident duck stamps totaled 51,670, while nonresidents purchased 50,207 stamps. Unlike fishing and general hunting license sales, waterfowl hunting did not see a dramatic rise and fall in participation during the last few years as a result of COVID-19. Total active hunters in the state are estimated through Harvest Information Program registrations and surveys. Through HIP data, the U.S. Fish and Wildlife Service estimates Arkansas had 56,500 active duck hunters last year, increasing



only 200 hunters from the year prior. When the margin for error in these estimates is calculated, they are essentially identical.

Duck harvest increases amid near-nationwide declines

The USFWS estimates last season's Arkansas duck harvest at 915,900, an increase from 2020-21's harvest of 889,000. This was not the trend with many other states typically known for high duck harvests. California, Louisiana and Texas all saw decreases in harvest, with the Texas harvest plummeting an estimated 58 percent. Arkansas's estimated harvest was second only to California, which claimed 929,800 ducks taken during their 100-day season with a more liberal seven-duck bag limit. The estimated seasonal duck harvest per hunter was 16.2 ducks, a slight increase from the 15.8 ducks taken per hunter during the 2020-21 season. This also ranks near the top in the nation as well, with only California (21.1 ducks per hunter), Oregon (19.2 ducks per hunter) and Louisiana (16.5 ducks per hunter) posting higher average harvests.

Arkansas again led the nation in mallard harvest, with 389,125 taken. The next closest state in mallard harvest was Washington, with 188,043 mallards reported. Missouri ranked third in mallard harvest with 177,561. Hunters in the nearby states of Kansas and Oklahoma harvested 235,307 mallards combined. Arkansas duck hunters harvested twice the number of mallards taken throughout the entire Atlantic flyway.

Arkansas tops list in specklebelly harvest

Arkansas goose hunters killed an estimated 152,200 geese, with 82,468 white-fronted geese, 11,070 Canada geese and 58,669 snow, blue and Ross's geese combined. This was the largest goose harvest in the Mississippi Flyway. The white-fronted goose harvest was the highest in the United States and accounted for more than 35 percent of total white-fronted goose harvest nationwide. Light goose conservation order hunters added an estimated additional 454,000 geese to Arkansas's harvest.

Licensing and Permits

A Waterfowl Hunter 16 or Older Must Carry:

1. A valid federal Migratory Bird Hunting and Conservation Stamp (\$25) physical stamp, signed in ink across the face, or the electronic code from purchasing the federal Migratory Bird Hunting and Conservation Stamp online (\$29). This option is only valid for 45 days from date of purchase until physical stamp arrives in mail;

And proof of the following license privileges (may be carried on paper, an electronic copy on the user's smartphone or through a Commission-issued Conservation Hard Card):

How Do I Buy a License?

- Licenses are available over the counter at AGFC regional offices, nature centers and many sporting goods stores across the state.



Telephone and online purchases must be made by credit card. Small game and fishing privileges become effective immediately. A valid printed license or acceptable electronic format license must be in your possession before hunting big game (deer, turkey, bear,

elk or alligator). Disability and commercial licenses are not available by phone or online.

What Kinds of Licenses or Permits Do I Need to Hunt in Arkansas?

If you are 16 or older, an Arkansas hunting license is required to hunt wildlife unless you are on a licensed game-bird shooting resort that supplies pen-raised birds. The license must be carried with you. If you guide, aid or assist someone else for pay or other value, you must have a guide license.

How Do I Replace a Lost License?

AGFC's licensing system allows license information to be retrieved via smart phone/mobile device. Purchasers can also print their own license at home or at license vendors around the state.

Do I Qualify as a Resident?

- Any person whose primary residence is in Arkansas and has been for the past 60 consecutive days (some licenses require longer residency)
- Full-time students of Arkansas schools, colleges or universities (with proof of enrollment)
- Residents that are full-time students of schools outside of Arkansas
- Active-duty military personnel and members of the National Guard who are assigned to an Arkansas Guard Unit
- Active-duty military who were Arkansas residents when entering service regardless of where they are stationed
- Owning property or real estate in Arkansas does not qualify a person as a resident.

What Are Disability Licenses?

Resident disabled hunters may purchase a three-year disability hunting license for \$25 or a three-year combination license for \$35.50 (includes fishing privileges) through the Little Rock AGFC office. Proof of 60 days' Arkansas residency or one year of residency for lifetime and proof of 100 percent total and permanent disability from the Social Security Administration, Department of Veterans Affairs or the Railroad Retirement Board is required.

What Is HIP Registration?

Each year, before hunting migratory game birds, hunters 16 years and older must register for the Harvest Information Program (HIP) at any AGFC office or online at www.agfc.com. Proof of Arkansas HIP registration must be carried while hunting.

Which Licenses Do Hunting Guides Need?

A guide is someone who guides hunters for pay or other consideration. Residents and nonresidents may not guide for waterfowl on any land owned or leased by AGFC or any NWR.

- Resident guide license \$25
- Nonresident guide license \$450

These licenses are available from all AGFC offices (see Page 1), online and at all license dealers; expire June 30; and do not include hunting privileges.

What Is a Nonresident WMA Waterfowl Permit?

In addition to a valid Arkansas hunting license, nonresidents must purchase a permit to hunt waterfowl on wildlife management areas during regular duck season (Page 44). The cost is \$30.50 for a five-day permit. The permit is valid only Nov. 19-27, 2022; Dec. 27, 2022-Jan. 5, 2023, and Jan. 21-Jan. 31, 2023.

Who Needs a Hunter Education Card?



A hunter born after 1968 must carry a valid hunter education card, unless 'HE-VERIFIED' is noted on your hunting

license. Hunters under 16 do not need to have a card if they are under the direct supervision of an adult 21 years or older. Arkansas honors the home state hunter education cards of nonresidents. Call 833-345-0325 or check

www.agfc.com for a class schedule. to replace a lost card visit ilostmycard.com or call 833-345-0325.

What Are Resident 65 Plus Lifetime Licenses and Permits?

Hunters 65 or older may purchase a lifetime hunting license. To hunt waterfowl, a state lifetime waterfowl permit (purchased once after age 65), HIP registration and federal waterfowl stamps are required. Licenses are available on the internet and at all AGFC offices, including nature centers. Customers must be an Arkansas Resident for one year to purchase.

Deferred Hunter Education Code

A free Deferred Hunter Education Code (DHE) can take the place of the hunter education requirement for hunters 16 and older. The code is available at any license purchasing agent, by phone or online:


- The hunter must possess a valid Arkansas hunting license while hunting.
- The hunter must be in the direct supervision of a licensed hunter at least 21 years old who is either certified in hunter education or was born on or before Dec. 31, 1968.
- The hunter may not have been convicted or forfeited bond for prior hunter education certification violations or other AGFC-sanctioned hunting privilege revocations.

Military Lifetime Licenses

Resident Military Retiree Lifetime Licenses are available at any AGFC regional office. Sportsmen must be 60 or older and show proof of one year of Arkansas residency and retirement from a branch of the U.S. Armed Services. Military lifetime trout and state waterfowl stamp permits, federal waterfowl stamps, resident trapping permits and HIP registration are not included with this license.

Resident Disabled Military Veteran Lifetime Licenses are available at the Little Rock office only. There is no age requirement for this license, but sportsmen must show proof of one year of Arkansas residency and proof of service-connected disability.



Ducks of Arkansas



Mottled Duck

Mottled ducks are rare in Arkansas. Drake and hen mottled ducks look like hen mallards, but the body feathers are a little darker than the mallard, yet not as dark as a black duck, and have the characteristic mottling shown in this illustration. The wing patch has a blue-green tint, no front white bar and a rear faded white stripe may be present.

Blue-winged Teal

Length - 16 inches

Look for rapid, twisting flight in dense flocks. Shoulders are pale blue. Less than one-third the size of a mallard. Most have migrated through Arkansas to Mexico and Central America by mid-October.





American Green-winged Teal

Length - 15 inches

The smallest duck seen in Arkansas. A fast duck that flies in dense flocks similar to those of blue-winged teal. Both sexes appear pale underneath and dark on top. Two pale lines on the top of wings are often visible. Teal prefer shallow water and are common in rice fields.





Avian Influenza Facts for Hunters

All hunters should be observant and careful when harvesting and handling wild birds, due to the possible presence of highly pathogenic avian influenza viruses.

In late 2021, a Eurasian strain of the HPAI virus arrived in North America. Cases have been confirmed in domestic birds, wild birds and wild mammals throughout the Mississippi Flyway.

Influenza experts expect a resurgence of "bird flu" as waterfowl migrations get underway. In other states, dabbling ducks are the most commonly infected waterfowl, but geese, swans, shorebirds, raptors and other species also can be infected.



Wild birds can be infected with HPAI and show no signs of illness. According to the U.S. Centers for Disease Control and Prevention, public health risk from HPAI remains low, but people should avoid handling any sick or dead birds found in the wild.

Safety Guidelines for Hunters

- Harvest only waterfowl that act and look healthy. Do not handle or eat sick animals.
- Field dress and prepare game outdoors or in a well-ventilated area.
- Wear disposable gloves while handling and cleaning game.
- Remove and discard intestines soon after harvesting and avoid direct contact with intestinal contents. Dispose of
 unwanted parts in a manner that prevents scavenging by domestic animals and wildlife.
- Do not eat, drink or smoke while handling carcasses.
- Wash hands thoroughly with soap and water after cleaning harvested game. If soap and water are unavailable, use alcohol-based hand sanitizer.
- Clean knives, equipment and surfaces that came in contact with game.
- Thoroughly cook all game to an internal temperature of 165 degrees Fahrenheit before eating it.
- After handling waterfowl, change clothes and footwear before coming into contact with domestic poultry.
- Immediately report any wild bird die-offs or sick birds to the AGFC's wildlife health program with coordinates of the location (agfc.health@agfc.ar.gov).



General Hunting Regulations

Captive Mallards and Live Decoys

It is illegal to hunt migratory waterfowl over live decoys at any time. It is illegal in Arkansas to release captive-reared mallards unless:

- The owner is operating and the hunter is shooting at a Commission-licensed game bird shooting resort.
- The owner has a valid shoot-to-kill retrieving dog training permit and legally purchased the mallards
 from the holder of a wildlife breeder/dealer permit or has legally imported the mallards into Arkansas in
 accordance with an AGFC wildlife importation permit. Shoot-to-kill retrieving dog training permits are
 available through any AGFC wildlife management employee or wildlife officer.

Transferring Wildlife

Each hunter's harvested waterfowl must be kept in a way so it is easily identifiable as belonging to that hunter. It is illegal to possess wildlife harvested by someone else, unless accompanied by a signed statement from the taker, stating name, address, species, date taken and license number. **See example at bottom of page.**

A driver's license number with state of origin may be substituted for the hunting license number. A hunter education card number or date of birth may be substituted for the hunting license number for hunters under 16 years of age.

Failure to Report a Hunting- or Trapping-Related Incident

It is unlawful for persons to fail to immediately report a hunting- or trapping-related incident involving personal injury above basic first-aid treatment to the Arkansas Game and Fish Commission so an investigation may be conducted.

If the incident involves only one individual and they are admitted to the hospital and incapacitated for any length of time, the incident should then be reported as soon as possible.



Wanton Waste

It is illegal to discard (or allow to go to waste) any edible portion of game birds taken.

Edible portions for game birds are breasts.



Legal Hunting Equipment

Legal Shot

Hunters may have only U.S. Fish and Wildlife Service-approved nontoxic shot in their immediate possession when hunting waterfowl.

Hunters may use only nontoxic shot size T (.2-inch diameter) and smaller when hunting waterfowl and coots. Other migratory birds may be taken with nontoxic shot size T and smaller or lead shot size BB (.18-inch diameter) and smaller.

Who Is Responsible?

Federal rules prohibit the taking of migratory game birds by the aid of baiting or over any baited area, if the person knows or reasonably should know that the area is baited. Hunters, guides and landowners are responsible for understanding and obeying regulations about baiting and knowing the conditions of the area to be burted.

Example: If a hunter hires a guide who has spread corn throughout the hunting area, but the corn is underwater where the hunter cannot detect it and reasonably had no knowledge that the bait was present, the hunter would not be guilty of hunting over bait. Hunters should ask guides or landowners if the area has been baited.

What Are the Penalties for Baiting?

Baiting migratory game birds is a criminal offense with fines up to \$200,000 and a one-year prison term. Hunting over a known baited area can result in fines up to \$15,000.

What Is a Baited Area?

A baited area is where salt, grain or other feed has been placed, exposed, deposited, distributed or scattered in such a way to lure or attract waterfowl or doves to, on or over any areas where hunters are attempting to take them.

An area is considered baited for 10 days following the complete removal of salt, grain or other feed.

What is the Difference in Field Preparation for Dove Hunting opposed to Waterfowl Hunting?

Agricultural crops may be manipulated for doves, but not for waterfowl and coots.

Dove hunting also is allowed over lands planted by means of top sowing or aerial seeding, if seeds are present solely as the result of a normal agricultural planting or a normal agricultural soil stabilization practice.

What About Normal Agricultural Operations?

Normal agricultural operations are those that have been conducted in accordance with official recommendations of state cooperative extension specialists. The University of Arkansas Division of Agriculture Cooperative Extension Service has a publication on normal agricultural operations at https://www.uaex.uada.edu/publications/pdf/FSA-9082.pdf.

Natural Vegetation vs. Planted Crops

Natural vegetation may be manipulated by mowing, disking or other means, but planted standing crops may not be manipulated. Millet is treated as an agricultural crop and may not be manipulated if it was planted that year. Millet that has grown on its own in subsequent years (called "volunteer") is considered natural vegetation and may be manipulated.

Ratoon Rice May Not Be Manipulated

Ratoon rice (additional rice grown as a second harvest from early maturing varieties) is treated as a standing agricultural crop. It may be hunted over, but may not be manipulated. Hunters should be cautious not to take any actions to intentionally scatter the grain of ratoon rice while hunting, placing decoys or accessing fields with standing ratoon rice.

Can I Put Up a Blind?

Hunters may conceal a blind on privately owned property using vegetation from agricultural crops or natural vegetation as long as it does not result in the exposing, depositing or scattering of grain.

Hunting from a boat is boating!

Remember to wear a life jacket and follow boating regulations.

Use of a Boat for Hunting



Anyone born after 1985 and of legal age to operate a motorboat must have successfully completed an

approved AGFC boating education course and carry proof of completion while operating any motorboat on Arkansas waters.

A motorboat is defined as any vessel operated upon water propelled by sail or machinery, whether or not the machinery is the principal source of propulsion. The boating education course teaches the fundamentals of safe and responsible boating and is written on a sixth-grade reading level.

The internet course is available online. Students study the material and take the examination in person. There is a \$29.95 charge.

After successful completion of one of these options, the student will be mailed a Boating Education Card.

Stop the Spread of Aquatic Invasive Species

- All boat plugs must be removed before leaving the loading area.
- Clean boats, trailers, decoys and other equipment thoroughly between hunting trips with hot soapy water, a high-pressure washer, or a light bleach solution (1 cup bleach to 10 gallons water).
- Let boats, trailers and other equipment fully dry for 4 to 6 hours, preferably in the sun.

- Tell other hunters and boaters about prevention and spread of aquatic nuisance species.
- Aquarium hobbyists and water gardeners should purchase native species instead of non-natives.
- Never release non-native plants or animals into the wild.

All plugs must the boat launce

All plugs must be removed from boats before leaving the boat launching area. This simple action will help prevent the spread of aquatic nuisance species like the invasive aquatic plant giant salvinia. Please help by doing your part by not only pulling your plug, but also cleaning any plants off of your boat trailer and hunting equipment that may be trying to hitch a ride!

Property Regulations

Hunting Near a Residence

Hunters lawfully present through ownership or lease agreement may hunt on their own property, regardless of distance to another person's residence.

However, all other hunters using firearms within 150 yards of a residence or using archery equipment within 50 yards of a residence must have written permission from the owner or occupant of that residence.

Hunting on Private Property

Written permission (see example below) from the landowner or leaseholder is required before hunting, fishing, trapping or releasing hunting dogs or pursuing wildlife with dogs on private property.

Written permission is not required if the person hunting is a relative of the landowner or leaseholder and permission can be verified.

Federal Regulations Overview

In addition to state regulations, the following federal rules apply to the taking, possession, shipping, transporting and storing of migratory game birds.



Special boating regulations apply on NWRs in Arkansas (see Page 44). It is illegal for waterfowl hunters to be guided on National Wildlife Refuges. Both hunters and guides are subject to penalties.

Caution: The following material is a summary. Each hunter should also consult the federal regulations found in Title 50, Code of Federal Regulations, Part 20 (available at https://www.ecfr.gov/current/title-50/chapter-l/subchapter-B/part-20). More restrictive regulations may apply to national wildlife refuges and state wildlife management areas.

Illegal Hunting Methods

You may not hunt migratory waterfowl:

- 1) With a trap, snare, net, rifle, pistol, swivel gun, shotgun larger than 10 gauge, punt gun, battery gun, machine gun, fish hook, poison, drug, explosive or stupefying substance.
- From a sink box or any other low floating device that conceals you beneath the surface of the water.
- From a motorboat or sailboat, unless you shut the motor off or furl the sail and the vessel is no longer in motion.
- 4) With a shotgun that can hold more than three shells, unless you plug it with a one-piece filler that cannot be removed without disassembling the gun.
- 5) From or by means, aid or use of any motorized vehicle or aircraft. If you are a paraplegic or are missing one or both legs, you may hunt from a stationary motorized land vehicle.

Dual Violation

A violation of a state migratory game bird regulation is also a violation of federal regulations.

Wanton Waste

You must make a reasonable effort to retrieve and keep all migratory game birds you kill or cripple while in the field. You must immediately kill any wounded birds you retrieve and count those birds toward your daily bag limit.

Rallying

You may not hunt migratory game birds that have been concentrated, driven, rallied or stirred up with a motorized vehicle or sailboat.

Tagging

You may not give your birds to another person in the field, regardless of whether or not they are properly tagged. You may not leave migratory game birds in the custody of another person unless you tag the birds with your signature, address, number of birds identified by species and the date you killed them.

Dressing

You may not completely field-dress waterfowl before taking them from the field. The head or one fully feathered wing must remain attached while you transport them to your home or processor.

Duck Stamp

If you are 16 or older, you must carry a valid federal Migratory Game Bird Hunting and Conservation Stamp. You must sign the stamp in ink across the face before hunting. Electronic proof of duck stamp purchases is valid only for 45 days after purchase.

Protected Birds

Federal law prohibits the killing of nongame migratory birds.

Special Waterfowl Permit Hunts

The AGFC manages a handful of public areas and private leases through a limited application and drawing process to reduce hunting pressure and increase hunt quality for those who are drawn. Visit www.agfc.com/waterfowlpermithunt for more details.

- · Applications are accepted through the AGFC's online licensing site, https://ar-web.s3licensing.com, from 3 p.m. Thursday until midnight Sunday of each weekend preceding the hunt date. Permits are drawn and notifications are sent each Monday.
- · Each hunter may submit one application for WRICE fields, one for WMA permit hunts, and one for WMA youth hunts (if applicable).
- · Each hunter drawn may have up to three additional people in their hunting party for the time specified on the permit.

WRICE Program

- · Interested hunters should visit ww.agfc.com/wrice to explore available fields.
- Successful applicants may hunt the field they are drawn for from 30 minutes before sunrise until sunset each day of the weekend drawn.
- · Hunters may not access WRICE fields outside of the days of their hunt; scouting by the roadside with binoculars is recommended.

Permit-based Youth Hunts

- Youth permit hunt areas are available at Sheffield Nelson Dagmar WMA (Page 56), Freddie Black Choctaw Island WMA West Unit (Page 51) and Steve N. Wilson Raft Creek Bottoms WMA (Page 57).
- · Youth permit hunt applications are only visible on the licensing site for users logged in under a youth hunter's Customer Identification Number.
- · Youth hunts require at least one adult mentor per party not to exceed one adult mentor per youth hunter.
- · Mentors may hunt with youths during these special permit hunts except during the annual statewide youth hunt dates (Dec. 3, 2022, and Feb. 4, 2023).

General WMA Regulations

A free annual WMA General Use Permit is required to hunt or trap on all WMAs. Permits are available online at www.agfc.com or by calling 833-345-0325 or any regional office.

Waterfowl Guides

It is illegal for waterfowl hunters to be guided for pay or other compensation on wildlife management areas, special use areas or national wildlife refuges. Both hunters and guides are subject to penalties.

Hunting Ends at Noon

Except where noted on pages 45-62, waterfowl hunters on WMAs may only shoot from 30 minutes before sunrise until noon from Nov. 19-Jan. 30. Waterfowl hunting is allowed 30 minutes before sunrise until sunset Jan. 31 as well as Dec. 3 and Feb. 4 (Youth and Special Active Duty Military and Veteran Waterfowl Hunts) on WMAs.

Waterfowl Hunter WMA **Access Times**

Waterfowl hunters must be off water-inundated areas or natural/man-made water courses by 1 p.m. (by noon on Dave Donaldson Black River WMA and George H. Dunklin Jr. Bayou Meto WMA) from Nov. 19-Jan. 30. Waterfowl hunters must be off water-inundated areas or natural/man-made water courses by 6:30 p.m. Dec. 3, Jan. 31 and Feb. 4.

No Equipment Left Overnight

Waterfowl decoys, dog stands and platforms may not be left out overnight on wildlife management areas, special use areas or wildlife demonstration areas, including river channels within exterior boundaries of WMAs. Boats in staging areas must be occupied, except slough boats at Dave Donaldson Black River WMA, which may be left at slough boat access points.

Nontoxic Shot Required

Federally approved nontoxic shot is required for ducks, geese and mergansers statewide. It is required for ALL migratory bird hunting on the following WMAs: Bell Slough, Beryl Anthony Lower Ouachita, Big Lake, Camp Robinson, Cut-Off Creek, Cypress Bayou, Dave Donaldson Black River, Dr. Lester Sitzes III Bois d'Arc, Earl Buss Bayou DeView, Ed Gordon Point Remove, Frog Bayou, Galla Creek, Harris Brake, Henry Gray Hurricane Lake, Petit Jean River, Rex Hancock Black Swamp, Seven Devils, Steve N. Wilson Raft Creek Bottoms, Sheffield Nelson Dagmar, Shirey Bay Rainey Brake and Sulphur River WMAs.

Vegetation Destruction Prohibited

On Commission-owned WMAs, it is illegal to use or posses chemical defoliants, chainsaws, handsaws, hatchets, axes, weed trimmers or other cutting devices. Screw-in tree steps and hooks also are not allowed. Exceptions to this rule include: hunting knives, pocketknives and pocket saws; campers in designated camping areas; and trappers using hatchets during trapping season.

Permanent Duck Blinds

It is illegal to build, erect or hunt from a duck blind (any structure fabricated from metal, lumber, wire, nylon or other building materials) which is not removed or torn down each day at the end of shooting hours. This applies to all WMAs including river channels within exterior boundaries of WMAs.

Special Youth, Active-Duty Military and Veteran Hunts

Hunting is allowed for only youths 15 and under as well as members of active-duty military and military veterans Dec. 3 and Feb. 4. All participants during these hunts have no shot shell limits on WMAs and may hunt from 30 minutes before sunrise until sunset on WMAs. Nonresident Waterfowl WMA Permits are not required for this hunt. See Page 4.

Certain Waterfowl Decoys Prohibited

From the first day of regular duck season until the end of regular duck season as well as early teal season, youth hunts and veterans hunts, it is unlawful on Commissionowned WMAs or lakes and on national wildlife refuges to possess, or take or attempt to take waterfowl with the use of any simulated wing movement decoy or any decoy with moving parts or electrical components; subjected to any artificial means that makes it appear to move, splash or cause ripples. Exception: Manually operated "jerk strings" may be used to simulate movement.

Simulated Wing Movement Decoys

Simulated wing movement decoys are any electric, mechanically operated, wind-powered, or manually powered apparatus or device that simulates wing movement, including any device that spins one or more fixed- or stationary-winged decoys around a central axis.

Nonresident 5-day WMA Waterfowl Permit

In addition to a valid Arkansas hunting license, nonresidents need a a valid Arkansas waterfowl stamp (DSN) and a 5-day Nonresident WMA Waterfowl Hunting Permit (NW5) to hunt waterfowl on all wildlife management areas. The permit costs \$30.50 and is valid only Nov. 19-27, 2022; Dec. 27, 2022-Jan. 5, 2023, and Jan. 21-Jan. 31, 2023. All hunters will also need a free WMA General Use permit when hunting on any WMA.

Boating Regulations on WMAs and NWRs

It is unlawful to operate a boat in any manner that is hazardous to persons or property on any part of a WMA or NWR including ramps, structures, boat lanes or other areas.


Examples of illegal boating practices include:

- 1) Weaving through congested vessel traffic;
- 2) Jumping the wake of another vessel too close to such other vessel;
- 3) Operating a vessel when visibility is obstructed;
- Moving at a speed that exceeds the safe and reasonable limits under the circumstances or that creates a hazardous wash or wake upon approaching or passing vessels;
- 5) Inattentive operation;
- 6) Failure to keep a proper lookout;
- 7) Failure to observe navigation rules;
- Swerving at the last possible moment to avoid collision where correction reasonably could have been made earlier;

- Operating while intoxicated or under the influence of any narcotic drug, barbiturate, or marijuana or while under any physical or mental disability so as to be incapable of operating safely under the circumstances;
- 10) Colliding with, striking or bumping another vessel, object or person;
- 11) Otherwise operating a vessel in a manner that endangers life, limb or property.
- 12) Impeding the normal and reasonable movement of boating traffic, except when reduced speed is necessary for safe operation or in compliance with regulations.
- 13) With the exception of meeting oncoming boats, all boating traffic must proceed in single-file with no passing allowed, exception when boats have exited the current direction of travel or are no longer under power.
- 14) All boating traffic on a WMA or NWR must maintain a minimum distance of 100 feet (approximately 6-boat lengths) between boats.

Any person found guilty of negligent operation (unintentional hazardous operation) may be fined \$250 to \$2,500, may be sentenced up to 60 days in jail and will be prohibited from accessing any WMA for one year from date of conviction.

Any person found guilty of reckless operation (intentional hazardous operation) may be fined \$500 to \$5,000, may be sentenced up to 90 days in jail, will be prohibited from accessing any WMA for one year from date of conviction and lose hunting and fishing privileges statewide for one year from the date of conviction.
